Being aware of these risks, I further hereby indemnify, release and hold harmless, MI Premier Dance Co. LLC (the Dance Studio), it's owners, staff, and assigns from any claims of liability relating to such injuries sustained while participating in activities connected with the Dance Studio both now and in the future. This includes, classes, rehearsals, performances, and any other activities during which myself/my child are under the care of the Dance Studio.
2. I confirm that I am the legal guardian of the minor for which this consent is being signed and I confirm that to the best of my knowledge my student is in good physical health and capable of participation in such activities.
3. I authorize, that in its normal course of business, the Dance Studio may take and use photographs, videos, and other representations of my and my child's likeness for promotional purposes without compensation to myself or my child. I understand that these images may be used in advertising via standard media, public relations and social media channels.
4. I confirm that I have carefully read this Agreement, Release from Liability and Assumption of Risk, and I fully understand the language contained therein, and agree to abide by these terms.

### **Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

MI Premier Dance Co. LLC (the Dance Studio) has put in place preventative measures to reduce the spread of COVID-19; however, the Dance Studio cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Dance Studio could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Dance Studio and that such exposure or infection may result in personal injury, illness, permanent disability, loss, damage, liability, expense, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Dance Studio may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the Dance Studio's employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Dance Studio or participation in its classes. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Dance Studio, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Dance Studio, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any of the Dance Studio's programs, classes or events.

\*In attending MI Premier Dance Co. LLC, I warrant, represent and swear that to the best of my knowledge, on behalf of myself and my child the following:

My child or I will not attend the Dance Studio within (14) days of having had any fever, cough, fatigue or other symptoms commonly associated with COVID-19:

My child or I will not attend the Dance Studio within (14) days of having had any contact with any family member or social acquaintance who has had any fever, cough, fatigue, or other symptoms commonly associated with COVID-19.

I understand that myself and my child will not be allowed to attend the Dance Studio within 30 days of testing positive for COVID-19 and I understand that I will not be reimbursed for services missed during this time.

I affirm that I have received a copy of the Dance Studio's Covid-19 Dance Class Guidelines and agree to abide by the guidelines during my attendance.

I agree to practice social distancing and clean hygiene during myself and my child's participation in services at the Dance Studio

By signing this agreement, I understand that if I am exposed to or infected by COVID-19 or any other infectious disease while on the premises of the Dance Studio, that I may have waived my right to lawsuit against MI Premier Dance Co. LLC, its owners, employees, agents, staff, and assigns as determined by a court of law.

I also affirm that I have had sufficient time to read and understand this document and obtain legal consultation regarding the agreement at my discretion.

## COVID-19 Dance Class Guidelines

Please read through these guidelines to update yourself and your child with our new procedures.

- Parents must conduct their own health assessment of their dancer prior to arriving to the studio. This includes taking temperature and making sure your child isn't experiencing any symptoms. The CDC has published the following as symptoms of COVID-19:
  - Fever, cough, shortness of breath or difficulty breathing, chills, repeated shaking, sore throat, and new loss of taste or smell
- Parents and students **MUST** wait in their cars until the previous class has vacated the building.
- Parents will not be permitted to wait in the studio. Dancers will have to be dropped off to the entrance and wait for your child's teacher to check them in (**ONLY 5 minutes** prior to class time). Parents may wait with their child outside until we allow dancers to come in.
- Students **MUST** be picked up promptly!
- Dancers are required to sanitize their hands upon entering the building, we will provide hand sanitizer.
- Students and staff will adhere to the six feet distance rule.
- Anyone age 6 and up **must wear a mask to enter the building**. This includes staff. **DANCERS WILL WEAR THEIR MASK WHILE IN BUILDING, I.E. BATHROOM, WAITING ROOM, AND CLASSROOM. DANCERS WILL BE GIVEN SMALL MASK BREAKS OUTDOORS WHILE SOCIAL DISTANCING.**
  - Teachers will wear masks during the entire class, as closer and further instruction may be warranted.
- **PLEASE** have your child use the restroom prior to coming to the studio. Being that parents will not be permitted in the building this makes it more difficult on staff. We are not encouraging bathroom breaks.
- Dancers are encouraged to bring their own water bottle labeled with their name. **No SHARING!**
- The studio will be sanitized in between classes in compliance with CDC Recommendations.
- Food is **NOT** permitted in the studio at **ANY** time.
- Students and Parents who travel outside of the country or to any known "hotspots" should self-quarantine for 14 days prior to returning to the studio or any events.
- All parents will need to sign a mandatory participation waiver before your child attends class.
